- I. <u>Call to Order</u>: The meeting was called to order at 3:30 pm by Jackie Gallagher.
- II. <u>Previous UFC Meeting Minutes</u>: Deb O'Dell sent corrections for minutes directly to Dave Henderson, UFC Secretary. The correction was minor and was made by Dave Henderson, UFC secretary. UFC approved minutes unanimously.
- III. <u>Reports</u>
 - a. **UMW President's Report:** The President's Report can be found <u>here</u>. The report addresses the following topics: Legislative Updates, Huron Engagement, and Enrollment for 2019-2020.

b. UMW Provost Report:

Comments on UMW 2019-2020 enrollment: Provost Mikhalevsky noted that this is currently yield season. She encouraged faculty to reach out to prospective students by sending cards or making phone calls. Provost Mikhalevsky emphasized the role of

faculty in meeting prospective students; contact by faculty makes a huge difference in helping students to come to UMW.

Applications to UMW: Provost Mikhalevsky addressed why UMW applications are decreasing. Bigger schools in VA (Tech, Mason, etc.) are taking more students now. UMW has also lost out on pricing to private schools. Many students are also living off campus, which affects retention. UMW name recognition has also diminished. Provost Mikhalevsky noted that one reason for the lower name recognition is that there was no marketing plan after UMW changed its name from MWC to UMW.

Conference at Randolph Macon: UMW SGA representatives attended a conference at Randolph Macon at which they met other SGA reps from around Virginia. They discussed challenges and shared ideas to improve student government.

Medical amnesty policy: SGA is finalizing the language of the medical amnesty policy and they hope to have this policy in place by the end of the semester.

UMW, can we talk: The SGA will talk with President Paino on 3/13 about tuition and fees. The SGA will talk on 3/20 with the General Education committee. The SGA will hold another talk again on 4/4, which will be part two on tuition and fees. All meetings will be held in UC at 3:00 pm in room 303.

UMW Campus Elections: The election process begins on 3/12 and elections will be held from 3/26-3/28.

V. <u>New Business</u>:

General Education Questions: UFC members asked Dr. Nicole Crowder, chair of the General Education Committee, about the current General Education initiative. Many of the questions focused on the language requirement. Dr. Crowder addressed the timeline of the forums. The General Education committee plans to give an updated to UFC at the 3/27 meeting. The General Education committee would like to have an electronic vote and will analyze data from second survey soon.

<u>Motion</u> for electronic ballot on general education curriculum: Dr. Crowder addressed the need for an electronic vote on the revised General Education curriculum. At the 3/27/2019 UFC meeting, the UFC will finalize timing for electronic vote. There was a friendly amendment to remove the date from the motion. Only full-time instructional faculty can vote. UFC unanimously passed this motion (without a date in the motion per the friendly amendment).

University Academic Affairs Committee:
