For example, for CE courses, in the section that asks faculty to explain how the course will meet the 15 hour outside of class requirement, could further state "faculty must communicate to students that successful completion of the course is only possible if CE actions are completed" or ask "how will you communicate to students that they cannot successfully complete this course without completing CE element?"
